Monte Fenner made a motion to approve the minutes from the July 19, 2023 session. Stephanie Gooden seconded. Motion carried 3-0-0.

Stephanie Gooden made a motion to approve the minutes from the Board of Equalization meetings on July 17, 2023 and July 19, 2023. Monte Fenner seconded. Motion carried 3-0-0.

Monte Fenner made a motion to approve a payment schedule. Stephanie Gooden seconded. Motion carried 3-0-0.

County Clerk Brittni Burton presented commission order #6425 in the amount of \$153,619.01 for a cash transfer of payroll, order #6426 in the amount of \$28,174.21 for 941 taxes and order #6427 in the amount of \$3,605.89 for CERF .7% and elective savings. Stephanie Gooden made a motion to approve the commission orders as presented. Monte Fenner seconded. Motion carried 3-0-0.

County Clerk Brittni Burton presented commission order #6428 as a letter of destruction on behalf of Building and Grounds Supervisor Zack Fletcher to remove an old wooden stool and a Casio calculator from the Recorder's Office, order #6429 on behalf of Auditor Karlin Breshears for a transfer of funds in the amount of \$1,276.18 from 10-35-5281-00 to 42-00-4075-00 in the amount of \$781.43 and to 42-00-4651-00 in the amount of \$494.75 for the April 2023 election on County sales tax of adult use marijuana, and order #6430 on behalf of Auditor Karlin Breshears for a transfer of funds in the amount of \$1,515.48 from 11-00-5596-00 to 10-00-4074-00 in the amount \$1,323.50, to 42-00-4075-00 in the amount of \$108.41, and to 42-00-4651-00 in the amount of \$68.64 for the April 2023 election on County Common Road District tax. Monte Fenner made a motion to approve the commission orders as presented. Stephanie Gooden seconded. Motion carried 3-0-0.

Monte Fenner made a motion to approve a liquor license for Holiday Lanes in Marshall/\$13. Stephanie Gooden seconded. Motion carried 3-0-0.

Sheriff Cindi Mullins submitted a request to hire Joshua Stemmons for a full-time position in the Jail Division. His start date is set for August 5, 2023 and his rate of pay will be \$15 per hour with a \$600 annual uniform allowance. Stephanie Gooden made a motion to approve. Monte Fenner seconded. Motion carried 3-0-0.

Becky Plattner stated she attended the quarterly RHSOC (Regional Homeland Security Oversight Committee) meeting. Grants were awarded to public entities that submitted applications. Some entities included emergency management departments, police departments, fire departments, and search and rescue departments. Grants funds to be awarded totaled \$96,808.73. Saline Emergency Management Agency was awarded \$1,750 out of the grant funds to maintain an existing radio system.


Monte Fenner stated he attended the Regional Bridge Committee meeting in Lee's Summit on July 27, 2023 to select submitted bridges to be funded for replacement. Saline County submitted two bridges to the committee and one bridge was selected. The bridge on 245th Road was built in 1910 and has been selected for replacement in 2025. Saline County has had three of five bridges selected that have been submitted to the Regional Bridge Committee in the last two years.

Stephanie Gooden stated as Vice President of Pioneer Trails she attended the executive board meeting of Pioneer Regional Trails Planning Commission on July 26, 2023. She also just returned from the National Association of Counties annual conference in Austin, Texas and as President of CCAM was

able to represent the County Commissioners Association of Missouri at the conference. She attended the Solid Waste Management District Region F meeting to discuss grants. As a member of the Transportation Advisory Commission, she completed the road needs for Saline County and submitted them to MODOT. MODOT voting for funding the submissions will be in September.

Recorder Jessica Baker announced her office recorded 228 documents and issued 14 marriage licenses for the month of July. They have also back indexed approximately 2,400 documents and put them online. She also asked for permission to use the Commission chambers on September 8-9, 2023 for US Imaging to be able to scan and digitize around 70 more old books, which would digitize documents to around mid-1948, as well as approximately 380 subdivision plats. Monte Fenner made a motion to close the Commission chambers on Friday September 8, 2023 for the scanning of documents. Stephanie Gooden seconded. Motion carried 3-0-0.

Stephanie Gooden made a motion to recess to adjourn at 12:00 PM. Monte Fenner seconded. Motion carried 3-0-0.
