Becky Plattner called the meeting to order and explained the purpose of the special session as being to approve two ordinances for MODOT’s Off-System Bridge Replacement and Rehabilitation (BRO) program to build two bridges in Saline County. The two bridges to be built through the program are Quince Ave and Mount Olive Rd.

Monte Fenner explained that MODOT has started to require any bridge to be replaced through the BRO program be put in an ordinance authorizing an agreement with MODOT before they can be put in their system to be built.

Monte Fenner made a motion to approve the ordinances for the Presiding Commissioner of Saline County to execute an off-system bridge program agreement to replace bridge number 3250021 on Quince Ave and bridge number 3530010 on Mount Olive Rd. Stephanie Gooden seconded. Motion carried 3-0-0.

Stephanie Gooden made a motion to approve the contract on behalf of the County Coroner with University of Missouri-Columbia to perform autopsies in the amount of \$28,675 to be paid in quarterly installments of \$7,168.75. Monte Fenner seconded. Motion carried 3-0-0.

Monte Fenner made a motion to approve the contract with accounting firm Gerding, Korte and Chitwood in Booneville to perform the County’s annual outside audit. Stephanie Gooden seconded. Motion carried 3-0-0.


Sheriff Cindi Mullins submitted a request to hire Zachariah Foltz for a full-time position in the Road Division. His start date is January 12, 2023 and his salary is set for \$39,520 with an annual uniform allowance of \$1,200. Stephanie Gooden made a motion to approve. Monte Fenner seconded. Motion carried 3-0-0.

County Clerk Brittni Burton presented commission order #6345 to amend commission order #5623 to remove former Presiding Commissioner Kile Guthrey from the Develop Saline County board and replace him with new Presiding Commissioner Becky Plattner. Stephanie Gooden made a motion to approve the commission order as presented. Monte Fenner seconded. Motion carried 3-0-0.

Collector Cindi Sims stated her office collected \$21,101,769.35 for December of 2022. Personal Property, Real Estate and surtax collections totaled \$14,731,043.50. Road and Utility collections totaled \$6,370,725.85. She stated credit card payments continue to increase every year and more people are paying online every year. She is working with their software provider to see if bills can start being emailed to citizens in 2023 as well as being mailed due to issues with getting bills delivered and bills being returned. By state statute bills will still have to be mailed.

Monte Fenner made a motion to recess to adjourn at 12:00 PM. Stephanie Gooden seconded. Motion carried 3-0-0.
