Stephanie Gooden made a motion to approve the minutes from the March 29, 2023 session. Becky Plattner seconded. Motion carried 2-0-0.

County Clerk Britni Burton presented commission order #6381 in the amount of \$156,459.93 for a cash transfer of payroll, order #6382 in the amount of \$28,264.05 for 941 taxes, order #6383 in the amount of \$3,687.59 for CERF .7% and elective savings and order #6380 in the amount of \$5,001 to add to the County's postage machine. Stephanie Gooden made a motion to approve the commission orders as presented. Becky Plattner seconded. Motion carried 2-0-0.

Stephanie Gooden made a motion to approve a payment schedule. Becky Plattner seconded. Motion carried 2-0-0.

Stephanie Gooden made a motion to approve the Saline County Fair Association to use the Courthouse lawn on June 3, 2023. Becky Plattner seconded. Motion carried 2-0-0.

Stephanie Gooden stated she had attended a legislative conference in Jefferson City on April 11, 2023 and is working with State legislators to address unfunded mandates to Counties.

Stephanie Gooden made a motion to approve the annual Emergency Management agreement between the County and the villages of Saline County which will provide the villages with Emergency Management services. Becky Plattner seconded. Motion carried 2-0-0.

Sheriff Cindi Mullins announced that the Saline County Sheriff's Department was just awarded a grant from the Department of Public Safety in the amount of \$1,838,339.51 to assist with the expense of jail maintenance. Stephanie Gooden made a motion to accept the grant. Becky Plattner seconded. Motion carried 2-0-0.

Prosecuting Attorney Tim Thompson requested the County Commission participate in a new settlement that is in progress, apart of the National Opioid Settlement. This new settlement is with Teva, Allergan, CVS, Walgreens, and Walmart and no estimates have been determined as to the amount to be received due to not having a final number of participants in the settlement. Stephanie Gooden asked if there would be a monetary impact to the local pharmacies. Tim Thompson responded that there would be no monetary impact but would imagine an indirect impact as far as policies and procedures. Stephanie Gooden made a motion to participate in the settlement. Becky Plattner seconded. Motion carried 2-0-0.

Recorder Jessica Baker announced her office has recorded 253 documents and has issued and recorded 9 marriage licenses for the month of March. They have also back indexed 2,905 documents and put them online.


Treasurer Jared Brewer gave a report on the various sales taxes received for the month of April. Sales tax collected in the amount of \$115,335.10. Law enforcement tax collected in the amount of \$86,501.60. Use tax collected in the amount of \$62,924.99. Sunset law enforcement tax collected in the amount of \$28,813.38. Economic development tax collected in the amount of \$115,251.32.

Auditor Karlin Breshears stated her Inventory Clerk is approximately 2/3 of the way through cataloging all Saline County property into the new inventory program.

County Clerk Brittni Burton presented the Collector's distribution report for the month of March. Total collections were \$297,250.81. In correlation with the distribution report, she had abatements and additions for the month of March. She also presented an auctioneer license for McCorkle Ag Sales LLC in the amount of \$55 for 12 months. Stephanie Gooden made a motion to approve the auctioneer license. Becky Plattner seconded. Motion carried 2-0-0. Stephanie Gooden made a motion to approve the additions and abatements for March 2023. Becky Plattner seconded. Motion carried 2-0-0.
