Becky Plattner called the meeting to order.

Becky Plattner asked for a motion to approve the minutes from the August 16, 2023 session. Stephanie Gooden made a motion to approve. Becky Plattner seconded. Motion carried 2-0-0.

Becky Plattner asked for a motion to approve the payment schedule. Stephanie Gooden made a motion to approve. Becky Plattner seconded. Motion carried 2-0-0.

County Clerk Brittni Burton presented commission order #6438 in the amount of \$154,290.56 for a cash transfer of payroll, order #6439 in the amount of \$28,455.34 for 941 taxes, order #6440 in the amount of \$3,584.40 for CERF .7% and elective savings. Stephanie Gooden made a motion to approve the commission orders as presented. Becky Plattner seconded. Motion carried 2-0-0.

Sheriff Cindi Mullins requested to hire Anna Miller for a full-time position in the Communications Division. Her start date is set for August 25, 2023 and her rate of pay will be \$15 per hour. She also requested to hire Anna Bullock for a full-time position in the Communications Division. Her start date is set for August 31, 2023 and her rate of pay will be \$15 per hour. Stephanie Gooden made a motion to approve both new hires. Becky Plattner seconded. Motion carried 2-0-0.

The Saline County Health Department nominated Nancy Marie Clements for the Saline County Health Department board. Her nomination was approved by the board at their July 2023 meeting. Becky Plattner made a motion to approve the appointment of Nancy Clements to the Saline County Health Department board. Stephanie Gooden seconded. Motion carried 2-0-0.

Becky Plattner announced that the Conflict of Interest ordinance is being renewed. This is an ordinance that is renewed every two years and is in accordance with RSMo 105.487. Becky Plattner asked for a motion to approve the renewal of the ordinance. Stephanie Gooden made a motion to approve. Becky Plattner seconded. Motion carried 2-0-0.

Stephanie Gooden made a motion to approve a liquor license for Holiday Lanes in Marshall/\$13. Becky Plattner seconded. Motion carried 2-0-0.

Recorder Jessica Baker stated a reminder that US Imaging will be at the Courthouse to scan plats and approximately 70 books from the Recorder's office on September 8 and 9. As requested and approved in the previous Commission meeting, US Imaging will be using the Commission chambers to do the scanning. The Commission office will be closed on Friday September 8, 2023.

Penny Shannon from the Assessor's office submitted a request to use the rotunda of the Courthouse on October 19, 2023 for the Marshall Chamber of Commerce's Trick or Treat on the Square event. Becky Plattner made a motion to approve. Stephanie Gooden seconded. Motion carried 2-0-0.

Collector Cindi Sims presented surplus funds from the 2023 tax sale held on Monday August 28th. 27 properties were offered this year. Four were not sold, one sale was voided, and one person backed out of their purchase. The 25% penalty for the winning bidder backing out on that property totaled \$724.58. The property will be up for sale again on Friday September 1st at 10:00 AM in the Courthouse rotunda. A total of \$27,106.04 in taxes and fees were collected. A total of \$62,402.77 in surplus funds were collected. A grand total of \$89,508.81 was collected for the 2023 tax sale. Three properties will be offered as an Over The Counter sale available on October 1, 2023.

Sheriff Cindi Mullins reported that the contractors for the Jail-Justice Center renovation were out for a finalization of the plan to get started on the project. There was a donation of eight Guardian Angel lights for road deputies for their safety. She also recognized Judge Harvey's drug court/mental health court project which has provided fresh fruits and vegetables to the jail.


Becky Plattner presented the finalization of the Commission's portion of the County inventory that was recently completed. The Commission's part of the inventory was approved and signed off on at this time.

The regular session was recessed, and the Commission immediately went into the 2023 Tax Hearing.

Becky Plattner called the Tax Hearing to order.

The State of Missouri's proposed tax rate for general revenue is 0.165. Saline County has adjusted the rate down to 0.149. The State's proposed tax rate for the Special Road Districts is 0.35. Saline County has matched the tax rate at 0.35. The State's proposed tax rate for the Common Road District is 0.2258. Saline County has left the tax rate at 0.2258. The State's proposed tax rate for the Common Road District temporary tax is 0.3458. Saline County has left the tax rate at 0.3458. The State's proposed tax rate for Senate Bill 40 is 0.0516. Saline County has left the tax rate at 0.0516. The State's proposed tax rate for County Wide Tax on Subclass 3 Property to replace M&M surtax is 0.4. Saline County has left the tax rate at 0.4. The total proposed revenue is budgeted at \$2,650,260.20. Stephanie Gooden made a motion to adopt the new tax rates. Becky Plattner seconded. Motion carried 2-0-0.

Becky Plattner asked for a motion to recess to adjourn at 12:00 PM. Stephanie Gooden made a motion to recess. Becky Plattner seconded. Motion carried 2-0-0.
