Becky Plattner called the meeting to order.

Becky Plattner asked for a motion to approve the minutes from the May 22, 2024 session. Monte Fenner made a motion to approve. Stephanie Gooden seconded. Motion carried 3-0-0.

Becky Plattner asked for a motion to approve a payment schedule. Stephanie Gooden made a motion to approve. Monte Fenner seconded. Motion carried 3-0-0.

County Clerk Brittni Burton presented commission order #6537 in the amount of \$174,863.96 for a cash transfer of payroll, order #6538 in the amount of \$32,017.73 for 941 taxes, and order #6539 in the amount of \$3,977.18 for CERF .7% and elective savings. Becky Plattner asked for a motion to approve. Monte Fenner made a motion to approve the payroll commission orders as presented. Stephanie Gooden seconded. Motion carried 3-0-0.

County Clerk Brittni Burton presented commission order #6540 to void and reissue check #117137 printed on March 29, 2024 in the amount of \$11,250 due to the vendor not receiving the check. Becky Plattner asked for a motion to approve. Stephanie Gooden made a motion to approve the commission order as presented. Monte Fenner seconded. Motion carried 3-0-0.

County Clerk Brittni Burton presented liquor licenses for City of Marshall, Indian Foothills Park and Rec in Marshall/\$256, Stone Hedge Golf Course in Marshall/\$506, Bloomfield's in Marshall/\$506, K Bar Family Restaurant in Emma/\$303, and Badger's Hideaway in Arrow Rock/\$256. Becky Plattner asked for a motion to approve. Monte Fenner made a motion to approve the liquor licenses as presented. Stephanie Gooden seconded. Motion carried 3-0-0.

Collector Cindi Sims presented the May 2024 distribution report. Collections totaled \$194,590.44. She also stated that certified mail will go out later this month for the 2024 tax sale. There are currently 169 properties eligible for the tax sale.

County Clerk Brittni Burton announced that she will start filling election judge seats for the August primary later this week. She is looking for approximately 80 election judges.

Becky Plattner reported that she attended the Pioneer Trails Regional Planning Commission annual meeting. They are doing very well and received an excellent rating on their audit for the year. She also attended the Missouri Department of Conservation (MDC) regular session on May 24<sup>th</sup>. She was there as a guest as a former Commissioner of MDC to represent all the former Commissioners to honor Director Sara Pauley who will be retiring on July 1, 2024. Sara Pauley is the first female director of MDC.

Becky Plattner asked for a motion to recess to adjourn at noon. Stephanie Gooden made a motion to recess. Monte Fenner seconded. Motion carried 3-0-0.
