Monte Fenner made a motion to approve the minutes from the January 4, 2023 session as presented. Becky Plattner seconded. Motion carried 2-0-0.

County Clerk Brittni Burton presented commission order #6347 in the amount of \$37,663.92 for December 2022 CERF fees collected, order #6348 in the amount of \$155,949.18 for a cash transfer of payroll, order #6349 in the amount of \$27,949.72 for 941 taxes and order #6350 in the amount of \$3,763.53 for CERF .7% and elective savings. Monte Fenner made a motion to approve the commission orders as presented. Becky Plattner seconded. Motion carried 2-0-0.

Becky Plattner announced the 2023 budget hearing will be held on Thursday February 2, 2023 at 11:00 AM along with the regular Commission session. The 2023 budget will be laid from January 23, 2023 to February 1, 2023 in the County Clerk's office.

Monte Fenner made a motion to accept the bid from CTS in Marshall from the bids for IT services that were opened on December 21, 2022 and were taken under advisement. Becky Plattner seconded. Motion carried 2-0-0.

Becky Plattner stated the Commission office will be closed on January 19, 2023 as to allow the Commissioners to host the West Central Commission meeting being held at Missouri Valley College.

Treasurer Jared Brewer gave a report on the various sales taxes received for the month of January. Sales tax collected in the amount of \$118,046.86. Law enforcement tax collected in the amount of \$88,535.43. Use tax collected in the amount of \$45,905.45. Sunset law enforcement tax collected in the amount of \$29,502.01. Economic development tax collected in the amount of \$118,001.96.

Monte Fenner made a motion to approve a payment schedule. Becky Plattner seconded. Motion carried 2-0-0.

Monte Fenner made a motion to approve a letter of destruction for a nonoperational printer from the Sheriff's Department. Becky Plattner seconded. Motion carried 2-0-0.

Monte Fenner announced Saline County will be receiving \$2,000,000 from Senator Blunt's office for the sewer project at the Marshall Junction.
